This is probably the easiest most effective way to make contact with a large number of potential R voters without ever leaving home. You can attend a Day of Action at Republican HQ in July to get training in person. See details about August 6th and 20th on Page 4 of this newsletter.

In January 2023 the 88<sup>th</sup> session of the Texas Legislature will go into session. The delegates at the Texas Convention in Houston selected eight of fifteen proposed priorities submitted to be 2022 Legislative Priorities. See County Chair Chris McNamara's report on Page 5 with the Priorities and more Convention News.

We will have to see what actually gets attention. Regardless, it is important that each one of us write to our representative and senator. Let them know what you think and as a voter and taxpayer what you want for your family and community. Remain in contact: one letter, email or call is not enough. If your issue did not make the top eight Priorities list, write, call, communicate however you can. Senator Brian Hughes and Representative Jacey Jetton have both made comments on Toni Anne Dashiell's Friday morning TAD calls about how communication with constituents has changed minds and votes.\*\*

I was sad to see that the proposed priority, **Securing The Grid**, which should be top priority, did not even make it to the final list of eight. This is something Senator Bob Hall has filed bills about for several sessions, addressing the vulnerability of our grid and the consequences to our way of life if the electrical grid goes down completely. It covers what can be done to protect the grid. Not easy but doable.

If you did not enjoy the freeze February 2021, then it would be helpful to watch Senator Hall's video, "Grid Down, Power Up". Go to Senator Bob Hall's website Scroll down to the until you see access to the video. You can zoom past the initial part. Stop when you hear Dennis Quade speaking. Check their Facebook page to see what's been done. Items will be distributed to all those working the border, including U.S. Border Patrol, DPS, Texas National Guard, and local Sheriffs' stations.

### BASIC ITEMS NEEDED

HAND SANITIZER SUNSCREEN INSECT REPELLENT WIPES

MICROBAN SPRAY POWDERED ELECTROLYTE (Gatorade, Liquid IV, Propel)

DISPOSAL GLOVES SNACKS (things that will not melt: crackers, chips, cookies, etc)

ITEMS FOR FIRST AIDE BAGS: suggestions:
Gauze, tape, eye wash, wound wash, antibiotics, chiggers/ insect medication. These can be individually given or put in a shopping bag.
They are taken out to the field stations for agents.
The .99 cent shopping bags at Walmart are perfect and easy to transport.

- 1. Contact your State Representative and State Senator (incumbent, elect, or November Candidate) and ask them to propose and adopt a rule to end the practice of appointing Democrat Committee Chairs.
- 2. Contact the Governor and Lt. Governor's offices as well as your State Representative and State Senator and let them know that you expect them to pass and sign into law meaningful legislation that follows the RPT Principles and achieves the goals of the Legislative Priorities and Platform. Tell them that will be the only

acceptable measurement of success for the 88th Legislature when you decide whether to re-hire them at the ballot box in the next election.

### **GENERAL MEETING MINUTES**

Cooke County Republican Women Regular Meeting • May 5, 2022

Location: First Christian Church, Gainesville

President Margaret Carter called the meeting to order at 7:06 pm.

Margaret welcomed members and guests and mentioned that questions for the forum were developed by the forum moderator and committee and that due to time constraints questions from the audience will not be taken.

The Invocation and Pledges were led by Cathy Hallmark, who mentioned that it is National Day of Prayer. Margaret mentioned that it is Miliary Appreciation Month and asked all Veterans to stand up to be recognized and appreciated.

Margaret then called on all elected officials and candidates to introduce themselves.

Chris McNamara, Cooke County Republican Party Chairman introduced himself and reported that the yearly fundraiser BYOG was very successful this year.

The April Meeting Minutes were approved.

#### Announcements:

Cathy Hallmark announced the club is collecting for the Border Patrol Project and requested donations. Pauline Lesch announced all upcoming elections.

Pauline Lesch moved on to the forum for the evening explaining that candidates would make opening statements, followed by questions and closing statements. The first two candidates were for the position of Commissioner Precinct 4 John Metzler and Matt P. Sicking.

Pauline explained that there is no incumbent in this race and the winner will not meet an opponent in the November election. Some of the topics covered were Roads and Bridges, Expected Growth, Budgeting and the possibility of a Bond Election and Tax Abatements.

Margaret announced a five-minute break for the audience and called members to the lectern to vote on a Bylaws change which was announced at the April 7 meeting. Bylaws Chair Dianne Helms explained that changes required by TFRW/NFRW require no vote. She then explained the change on which the members needed to vote, to give the authority to make changes to the regular meeting schedule to the Executive Committee, rather than to the President alone, and to provide a requirement to notify the members of such a change in no less than seven (7) days. Members voted to approve the change.

The forum continued with the race for the position of County Judge and the two candidates Leon Klement and John O. Roane. Pauline announced that there is also no incumbent for this race but that the winner of this election will meet an opponent in the November election.

The same format was followed and some of the topics covered included The Candidates Top Priorities & Expected Biggest Challenges, Tax Rates, Emergency Management, and the Candidates Confidence in Cooke County Elections.

The meeting was adjourned at approximately 9:45 p.m.
